Notes Differences between ending and beginning census and/or absence totals are due to transactions posted after the end of a reported month and/or year.

Report ending census/absence cannot be computed by adding and/or subtracting admissions, absences and/or discharges. The beginning and ending census are independently calculated.

Report counts only MH persons at Rio Grande State Center.

NEW ADMISSIONS	The following are for new admissions – persons not transferred from another campus-based facility.
VOL ADM	Number of voluntary admissions to the component during the period.
RESPIRE ADM	Number of persons admitted to respite care during the period.
INVOL ADM	Number of persons admitted involuntarily during the period.
ADM SUBTOTAL	Total number of persons admitted during the period.

ASA	Number of persons absent for a therapeutic special activity.
ATV	Number of persons absent due to a therapeutic home visit.
DISCHARGES <u>WITH REASSIGNMENT</u> REFERRAL	(Duplicated count) Number of persons discharged with reassignment but not to the authority.
AUTHORITY	Number of persons discharged with reassignment to the authority (county of residence).
<u>AGAINST MED ADVICE</u>	Number of persons discharged against medical advice.
<u>NO MORE SERVICES</u>	Number of persons discharged with no more services.
COM PLACEMENTS	Number of community placements during the period.
DISCH SUBTOTAL	Number of all discharges for each month.
DEATHS	Number of deaths during the report period.
END CENSUS	Number of persons in residence at end of the report period.
END ABSENCES	Number of persons absent at end of the report period.
